Dependent Care

Do you have dependent care issues conflicting with your normal work schedule? You have options:

- **Request CPAL or FFCRA paid leave hours intermittently:** Individuals, who have school age children distance learning and/or daycare closures, may use CPAL or FFCRA paid leave during periods you are unable to work. Consult with your supervisor and [submit leave request](#) to Human Resources
- **Request an adjusted schedule:** President Junn has asked that affected staff notify your manager as early as possible if you need an adjusted schedule (i.e. require a 2-hour break during the day or 4-hours on minimum days). Managers should make every effort to be flexible.
