Membership Authorization: **Yes, I want to join with my fellow employees and become a member of the California State University Employees Union (CSUEU), SEIU Local 2579, CSEA.** I hereby request and voluntarily accept membership in CSUEU and I agree to abide by its Bylaws and policies, and by the Service Employees International Union Constitution and Bylaws. I authorize CSUEU to act as my exclusive representative in collective bargaining over wages, benefits, and other terms and conditions of employment with my employer.

Dues Deduction/Checkoff Authorization: I recognize the need for a strong union and believe everyone represented by our union should pay their fair share to support our union's activities. I enter into this agreement in return for the privileges of CSUEU membership and the long term benefit of union representation. I direct my employer to deduct membership dues from my earnings, and to transfer that money to CSUEU. I can end my membership by following the instructions in my union contract (found at [CSUEU.org](http://CSUEU.org)), or as otherwise allowed by law. I understand that both union members and nonmembers benefit from representation and should contribute. If I resign my union membership and the law no longer requires nonmembers to pay a fair share fee, I nevertheless agree voluntarily to contribute my fair share by paying a service fee in an amount equal to dues. I direct my employer to deduct this service fee from my earnings and to transfer that money to CSUEU. I understand that this voluntary service fee authorization shall renew each year on the anniversary of the date I sign below, unless I mail via U.S. mail a signed revocation letter to CSUEU's central office, postmarked between 75 days and 45 days before such annual renewal date.

PAC (Political Action Committee) Authorization: **Hold Politicians Accountable!**

**Yes!** I am volunteering to contribute to PAC to help make elected officials stand up for working people. My contributions will be used to support member endorsed candidates and for expenditures in connection with addressing political issues of public importance, elections for local, legislative, statewide and federal offices. I authorize my employer to deduct the amount identified every pay period and transfer the funds to ("CSUEU PAC"). A portion of this contribution may be used by CSUEU for federal elections. The contribution amounts indicated below are only suggestions and I may choose not to contribute or to vary my contribution amount without reprisal from my Union or my employer. As per federal law, only union members and union executive/administrative staff who are U.S. citizens of lawful permanent residents are eligible to contribute to CSUEU PAC. This authorization is made voluntarily and is not a condition of my employment or membership in the Union. This authorization shall remain in effect until revoked in writing by me via U.S. mail to CSUEU. This contribution is in addition to union dues. My signature shows that I agree with the terms.
