- Furlough update: Pat Gant sent a letter to the Chancellor's Office, but nothing has been decided. Furloughs have not been bargained as of yet for 2010-11 school year. Layoffs have already been announced an some campuses so if these notices have gone out, furloughs probably won't happen again.
- We have hired 2 accountants and someone to take Bob Roses position, all have joined as members of CSUEU
