- Chapter Elections (Rick) Election process was discussed. Information will be sent out to members and will be available on the CSUEU Chapter website. Nomination Period is now open and ends at 12:30 PM on 2/8. Positions are 3 year terms and are for the Executive Committee officers and General Council reps. There will be an info session at the February 1<sup>st</sup> Executive Committee meeting. Headquarters will send ballots out to members and results will be announced sometime in March or April.
- State Budget Update (Frank) State of California has a deficit of \$9.2 Billion, less than what was anticipated. Governor is proposing a \$7 Billion tax increase (tax the rich, sales tax increase). If tax increase passes state will be in better shape. If it doesn't pass then there could be \$200 million cut to the CSU system. Governor has a 12 Point plan on pension reform, a couple points which might affect our member's pensions. May Revise (in March or April) will give us a better idea of how things are going and how it might affect us.
- **CSUEU/CSU Contract Bargaining** (Frank) Bargaining Team passed 17 articles to CSU, 13 tentative agreements made. 4 articles with no agreements: Salary Structure, Parking Fees, Contract Duration and Contracting Out. Link
